Automatic Savings

With Automatic Cash Transfer (ACT) from the Church Extension Fund, you can enjoy completely automatic savings by having funds withdrawn from your bank account on a regular basis, and deposited directly into your Dedicated Savings or Variable Rate Term Note account.

You may have your checking or savings account debited at your local bank on the 10th, 20th, or last day of the month (or on the second next business day thereafter) and the funds will be automatically transferred to your CEF account.

You will receive a mailed receipt for every transaction, and all transactions are reflected on your semi-annual statements as well.

Automatic Interest Deposit

In the same manner, you can enjoy the safety and convenience of having the interest earnings from your Fixed or Variable Rate Term Note account deposited directly into your checking account at your local bank. Gone are the hazards of sending checks in the mail...checks that can be lost, mislaid, or even stolen!

Automatic Withdrawals

Another benefit of ACT is the option of automatic withdrawal of a predetermined amount from your CEF savings on a monthly or quarterly basis. These funds can be deposited directly into a checking or savings account elsewhere...a safe and convenient way to provide financial assistance to a college student or loved one away from home.
